This table shows what is available on the *first* business day of the ensuing month. The state accounting system closes each month on the *fifth* business day of the ensuing month. State agencies responsible for reporting revenues to DFM have agree that the *tenth* business day of the ensuing month is a reasonable target for providing data to DFM.

Consequently, revision to the preliminary data presented here could, and should, be expected.
