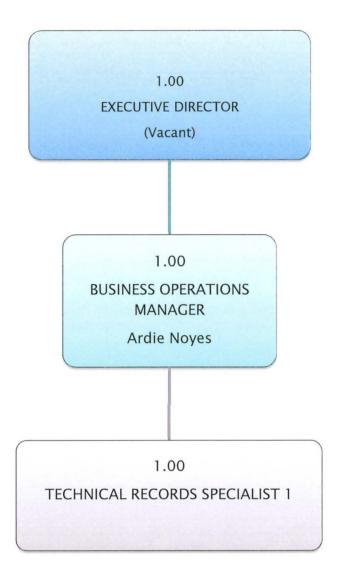

Explain the request and provide justification for the need.

The Racing Commission requests an ongoing dedicated spending authority for inflationary increase for vet and lab fees,

Costs for multiple types of testing including hair and blood testing have continued to rise. The Commission requires blood and hair samples be pulled from horses participating in Pari-Mutuel racing within the state. Lab fees for hair and blood testing recently increased by \$25 per test resulting in additional yearly costs of \$15,000.

Additionally, many testing laboratories are no longer paying for the continued shipping of samples back and forth as was standard practice prior to the pandemic.

Recently, urine testing has been added as a requirement for select races which has resulted in contractual vet fees increasing substantially as more assistants are needed to complete this task. Vet services have risen from \$1,000 per day to a minimum of \$1,500.00 per day.

With increased race days and increased costs the commission does nto have enough spending authority to cover the increased costs.

If a supplemental, what emergency is being addressed?

Specify the authority in statute or rule that supports this request.

54-2507. AUTHORITY OF COMMISSION. (1) The commission created by this act is hereby authorized and it shall be its duty to license, regulate, and supervise all race meets held in this state under the terms of this act, and to cause the various places where race meets are held to be visited and inspected at least once a year.

(2) Notwithstanding any other provision of this chapter, the commission may authorize any licensee to participate in an interstate common wagering pool with one (1) or more other racing jurisdictions. Anytime that a licensee participates in an interstate pool, the licensee may adopt, with the authorization of the commission, the take-out of the host jurisdiction or facility.

(3) The commission may permit a licensee to use one (1) or more of its races for an interstate common wagering pool at locations outside its jurisdiction, and may allow pari-mutuel pools in other states to be combined with pari-mutuel pools in its jurisdiction for the purpose of establishing an interstate common wagering pool.

The Racing Commission exists to provide regulation in an equitable manner to Idaho's Pari-mutual horseracing industry; to protect the interest of wagering patrons and the State of Idaho in a manner which promotes a climate of economic prosperity for horsemen, horse owners and racetrack management. Non-permitted medications cannot only be a danger to the animal, but also a danger to the betting public. Testing is a continually changing procedure to all aspects of Horse Racing. Currently the Commission tests horses in 3 different categories, those being Hair, Blood, and

Explain the request and provide justification for the need.

Racing Commission requests \$400 for it's portion of the the annual UPS (Uninterrupted Power Supply) maintenance for all ISP UPS statewide. This includes maintenance, battery/capacitor replacement, and on-call service for outages. These UPS currently provide stable sustained power to critical support areas including both the ISP data center in District 1, both RCCs in Districts 1 and 3, and all three Forensics labs in Districts 1,3, and 5. The data center at HQ and both RCCs have been identified as critical infrastructure by a Department of Homeland Security Vulnerability Assessment.

ISP Currently has \$5,700 in the current budget among all different funds however, the service level agreement for maintenance was severely misquoted and it resulted in unsatisfactory maintenance of all UPS agency wide. This request will ensure there is sufficient budget for the Racing Commission to cover it's portion of the full maintenance contract capable of meeting mission requirements for critical infrastructure.

UPS maintenance is critical as when there is a power outage, ISP needs the backup to keep systems running 24/7. Without this maintenance anytime power is out, ISP would be at the mercy of the power company and operations would pause.

The FY23 staffing for Racing Commission is 3.00 FTP; funding is \$437,800 in dedicated funds. There is no funding in the base for this request.

The entire agency is being served by this request, but more important is to meet a requirement to provide sustainability to critical ISP infrastructure. Should power be interrupted by technical deficiency, man-made or natural disaster, without fulfillment of this request the RCCs and the ISP data center would be unable to support the mission. There would be no dispatch capabilities, no IT connectivity, and the inability of Forensics Sciences to perform their mission.

Part I - Agency Profile

Agency Overview

The Idaho State Racing Commission was created to enhance, promote and protect the live race industry in the state of Idaho. Our mission is accomplished through licensing; regulations and supervision of all live and simulcast race meets in this state under the terms of the Horse Racing Act, *Idaho Code*, Title 54, Chapter 25.

The Racing Commission is comprised of three members appointed by the Governor and confirmed by the Senate for six-year terms. The Executive Director is appointed by the Director of Idaho State Police, who then in turn hires and manages the office staff and part-time regulatory personnel, under the direction of the Idaho State Police. Since February of 2015 the commission has been without an Executive Director. Remaining employees are 2 full time administration persons, (1) seasonal part-time licensing clerk, and (3) three part-time seasonal stewards to perform the day-to-day operations. The Racing Commission's office is located in Meridian at the Idaho State Police facility. A small satellite office was opened in Blackfoot in late 2021 to better serve the industry as most live horse racing occurs in the southeastern part of our state.

The Idaho State Racing Commission is a dedicated fund agency with its revenue coming from a percentage of the pari-mutuel handle, licensing fees and fines. Revenue is driven by the industry.

Revenues for the Commission have been very low in the past several years due to the closure of the largest track located in the heaviest populated area of the state. During the 2021 regular session of the 65th Idaho Legislature, SB1178 was brought forward by the industry as a way to better fund the Commission. This change amended existing law to provide for a retention of a percentage of advance deposit wagering monies by the Idaho State Racing Commission for racing administration. The legislation passed and was signed by the Governor on May 5th, 2021. The industry continues discussions on other possible revenue streams which will help continue to fund this long held tradition in Idaho alive.

Core Functions/Idaho Code

The Idaho State Racing Commission has authority to prepare and promulgate a complete set of rules and regulations to govern race meets in order to ensure the individuals who participate at race meets will act in the best interest of racing. It is the duty of the Racing Commission to license, regulate, and supervise all race meets held in this state. (Title 54, Chapter 25, Idaho Code)
